That the activities take place on rough and uneven grounds, and Willow Park Church Mennonite Brethren and The British Columbia Conference of the Mennonite Brethren Churches and the property owners do not provide any assurance that the grounds are safe. I promise to be responsible for moving carefully on all grounds, and moving only at a speed such that I can take all necessary care;

\_\_\_\_\_5. That the other Participants may engage in conduct that is dangerous to me, and the operators cannot supervise the behavior of others, and I accept the risk that others may cause me harm deliberately or accidentally.

\_\_\_\_\_6. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those organizations and persons released from liability below, and assume full responsibility for my participation.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Willow Park Church Mennonite Brethren and The British Columbia Conference of the Mennonite Brethren Churches, the owners of the property used to conduct the paintball activities, their officers, officials, agents and/or employees ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property arising out of, connected with, or resulting from the paintball activities, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the result of gross negligence and/or wanton misconduct. I further agree to indemnify the Releasees against any and all claims, procedures, costs, expenses (including legal fees and expenses), damages and liabilities arising out of, connected with, or resulting from the paintball activities.

\_\_\_\_\_8. I hereby certify that I am in good health and do not suffer from a heart condition or other ailments which could be aggravated by exertion involved in participating in the paintball activity.

I acknowledge that the forgoing release is intended to be as broad and inclusive as is permitted by the law of the Province of British Columbia, and that if any portion thereof is held to be invalid, it is agreed that the balance shall, nevertheless, continue in full legal force and effect.

\_10. I hereby certify that I am at least 19 years of age and in good mental and physical health and if I am 18 years of age or younger, I will have a Parent's or Guardian's signature provided below giving permission to participate in the activity and agreement to this waiver.

I certify that I have read the terms and conditions set forth on this release of liability and assumption of risk agreement in its entirety and fully understand its terms, understand that I have given up substantial rights by signing it and sign it freely and voluntarily without any inducement and that I have executed the same of my own free will without any duress whatsoever, realizing that it is a legally binding agreement.
